

## GENERAL RULES OF XIX S.E.K. CONVENTION

- The Board will be the ultimate responsible for the organization and development of the convention.
- The Board of S.E.K. with no fewer than 3 of its members and always attended by the chief justice, judge will be responsible for any incident that may occur during the holding of the convention.
- Its decisions will be made in the shortest time possible and without appeal.

### EXHIBITION COMPETITION PROCEDURE

#### "Tender procedure-exposure"

Article 1. - Killifish may submit to the contest, a person belonging to the SEK or any other related group with the world of the killifish, national or international.

Section 2. - No contest may be submitted to overexposure PROTECTED SPECIES (unless there is express permission of the competent authorities) for regional or state laws.

Section 3. - Fish, written material and photographic material participating in the contest-exhibition and the Convention shall become the property of SEK

Section 4. - The S.E.K. have full right to publish or assign to various associations photographic materials from their contests with only one obligation: to publish the name of the author of such work.

Section 5. - The composition of the groups is the responsibility of the Board and will always be open in anticipation of possible changes.

Section 6. - They may be all the species belonging to the order Cyprinodontiformes:

Poeciliidae: Aplocheilichthyinae, popularly known as Killifish.

Fish may participate in the convention in different ways:

Exposure mode.

Contest-exposure mode.

6th-exposure mode: This mode may be submitted all species of killifish without any requirement. The fish shown in this embodiment will be exhibited and auctioned have no choice but to be rewarded. Have an identification tag with the name of the donor to public knowledge of their generous gesture.

6.b-contest-exposure mode: Participation in this section all fish reared since he was a juvenile to maturity in tanks owned by the breeder to submit them.

These species will be displayed, auctioned and scored. Likewise, will obtain rewards options described for this embodiment.

May not participate in this mode:

a) wild fish.

b) Fish awards at other conventions.

c) Fish that as a pair or group of breeding, not of the same species or population if any.

*Note: Because it is currently impossible to prove the truth of the requirement described in contest mode, exposure, SEK this requirement based on trust and good will of the breeder.*

*However, this point may be amended according to available means or agreements with other associations.*

-In the category of pairs, the fish can be presented as pairs or one male accompanied by several females, puntuándose best male and female.

-In the case of breeding groups should be formed by at least three pairs or two trios (two males and four females).

Each pair of fish-breeding group or entered into the competition shall be identified with the following data: association that owns the contestant and their membership number and species, subspecies and population of the specimens. The false data may result in disqualification.

The specimens at the time of trial no partner or partners constituting death of a fish, will not be judged, although auction, if the contestant does not exercise its right to withdraw the rest of live.

-The convention program set a time as limit fish intake to tender.

-Until the opening to the public only have access to the exhibition hall, the organizers, the editors and at the time of judging, the judges.

Once registered, contestants fish will not be accepted any changes in fish submitted.

6.c-only know the origin of fish responsible for the reception and registration. Judges shall not be informed about ownership of the fish.

Article 7. - Each group will be judged by two judges preferably.

7th-The judges are chosen by the Board among the invited members of other associations and between the members of the SEK and can not judge any group in which concursen.

7.b-The judges' decision is final.

Article 8. - The fish will be judged rated from one to ten, taking into account the following sections:

- a) Health and general condition of the fish.
- b) Size and general conformation.
- c) Pattern of color.
- d) General condition of the fins.

Article 9. - In the event that any of the top three in each group had a tie, would correspond to the judges who rated the group's final decision.

Article 10. - After the count of points obtained by all the fish, whenever feasible technical and resource availability, will be released a list of the following sections:

- a) Number of fish.
- b) Name and population, if any.
- c) Name of breeder.
- d) Association with which the breeder has been submitted.
- e) end points obtained.
- f) Classification (only the first three).

### "Awards"

Article 1. - Will be given a first, second and third prizes for each group of Killifish. In the event that breeding groups are distributed among different groups of killifish, is given a unique first prize for the best breeding group from each group contest.

Section 2. - Will be given a single award for the best fish of the convention.

To be eligible for this award must have achieved the first prize in any of the groups.

2nd-The composition of the jury for this award will be decided by the Organizing Committee. It will be the president of the S.E.K. responsible for deciding on a possible tie.

Art.3. - Will power the Organizing Committee and / or Board of Directors to convene the photo contest.

This photographic material will be freely available for SEK in all publications, regardless of its format.

Section 4. - The choice of format of the awards according to the group organizer.

### Composition of the groups in competition:

- Group I: Callopanchax, Fundulopanchax, Gularopanchax, Paludopanchax, Paraphyosemiony, Raddaella.
- Group II: Archiaphyosemion, Mesoaphyosemion (Group Callirium) and Scriptaphyosemion.
- Group III: Aphyosemiony Mesoaphyosemion (except Group Callirium).
- Group IV: Chromaphyosemion, Diapterony Kathetys.
- Group V: Aphyoplatys, Aplocheilus, Epiplatys, Episemiony Pachypanchax.
- Group VI: Rivulus.
- Group VII: Fundulosomay Nothobranchius.
- Group VIII: Annual American.
- Group IX: Aphanius.
- Group X: Other.

*NOTE: This year breeding groups disappear as such and shall be distributed among all groups of killifish aconcurso, giving a single first prize for the best breeding group each gruposparticipantes.*

Rights and duties of participants:

All participants will have the following rights:

- Be entitled to receive any information requested concerning all convention activities.
- Have the right to claim when considered unjustly treated or suffer any impact.

All participants will have the duty to:

- Use facilities with good treatment and proper care.
- Help keep the facility clean, using paper and hygienic containers.
- Respect and care for all furniture.

- Save all due respect to the participants and the general public, noting the composure necessary for the successful coexistence.
- Respect the hours of operation of the facility, following the indications of the employees and the organization.
- Accept and few rules and instructions issued by the Board or the organizing group.

## AUCTION

The auction procedure will be for the hands, as is customary in previous conventions.

The order in which groups will be auctioned:

- Group I: Callopanchax, Fundulopanchax, Gularopanchax, Paludopanchax, Paraphyosemion y Raddaella.
- Group II: Archiaphyosemion, Mesoaphyosemion (Group Callirium) and Scriptaphyosemion.
- Group III: Aphyosemion y Mesoaphyosemion (except Group Callirium).
- Group IV: Chromaphyosemion, Diapterony Kathetys.
- Group V: Aphyoplatys, Aplocheilus, Epiplatys, Episemion y Pachypanchax.
- Group VI: Rivulus.
- Group VII: Fundulosomay Nothobranchius.
- Group VIII: Annual American.
- Group IX: Aphanus.
- Group X: Othe.

From Group I to Group IX (pairs, trios or male with several females), will be auctioned for an amount of 3 €, rising 1 € to reach 20 € from this figure will increase by € 3 each bid that the amount of the auction reaches 50 € the increase will be 5 by 5 €.

Groups of breeding will be auctioned for an amount of 6 €, rising 1 € to reach 20 € from this figure will increase by € 3 each bid as the amount of the auction reaches 50 € the increase shall be 5 by 5 €.

As for the special auction of rare species to be held on Saturday April 28 at 18:00. The output value of each stock (fish or peat) will be decided by the donor, rising 1 € up to € 20 from this figure will increase by € 3 each bid as the amount of the auction reaches 50 € the increase will be 5 by 5 €.

The fish is always paid in cash, which may not otherwise pay.
